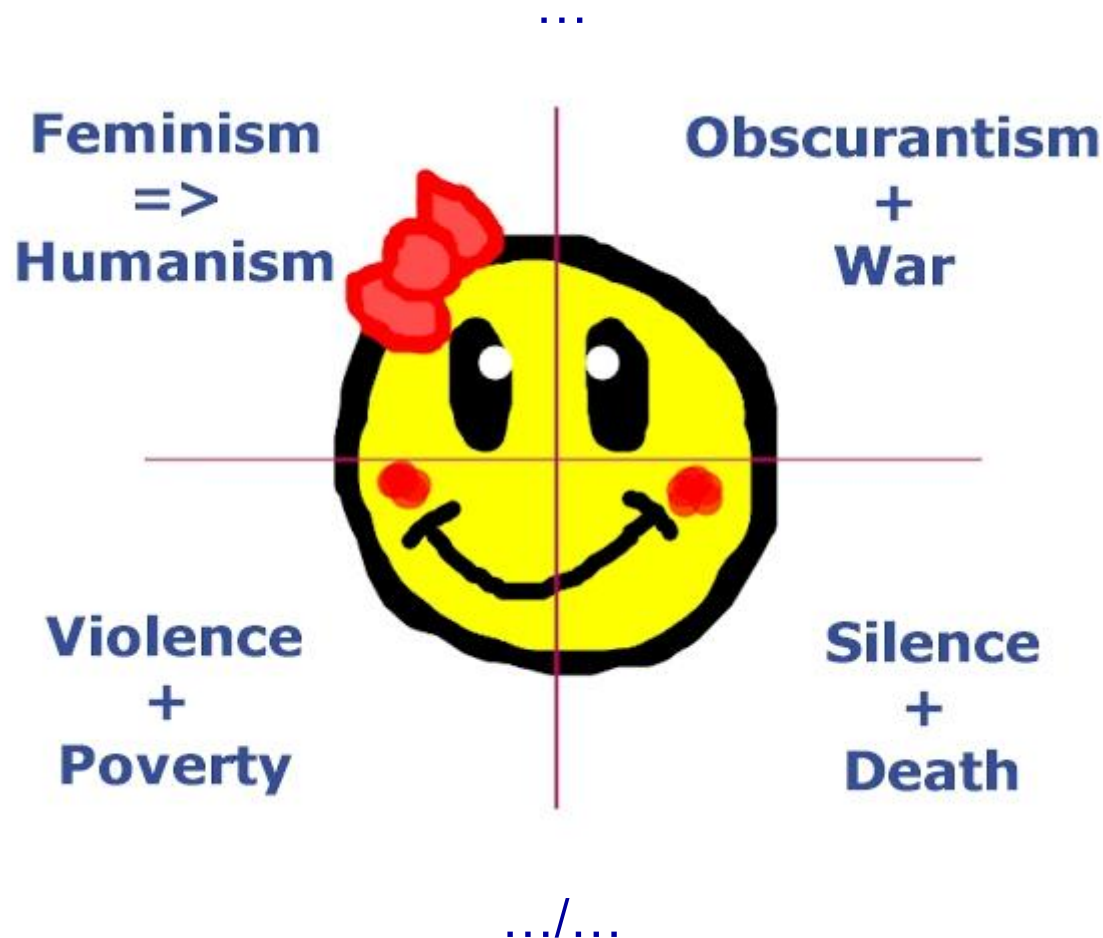

## 5. Millennium2015, a global foresight process empowering gender equality

Full title: Millennium2015, Women actors of development for the global challenges  
=> women do not present themselves as victims but as actors and architects of the futures

"Millennia2015 is a global operation and a great network enveloping the entire globe, in search of what women have in common and, at the same time, acknowledging the differences and gearing such differences towards sharing the objectives. It recognizes the role of women as well as women's enhancement as social actors that can make a difference and not mostly as victims, as still often thought. Millennium2015 shows women themselves and the world, that they can bring change towards a more human and sharing community".

The foresight methodology is developed with Philippe Destatte, director general of The Destree Institute, in charge of the foresight course at the University of Paris-Diderot and at the University of Reims Champagne-Ardenne.



## 6. Millennium2015: the inclusive foresight research process

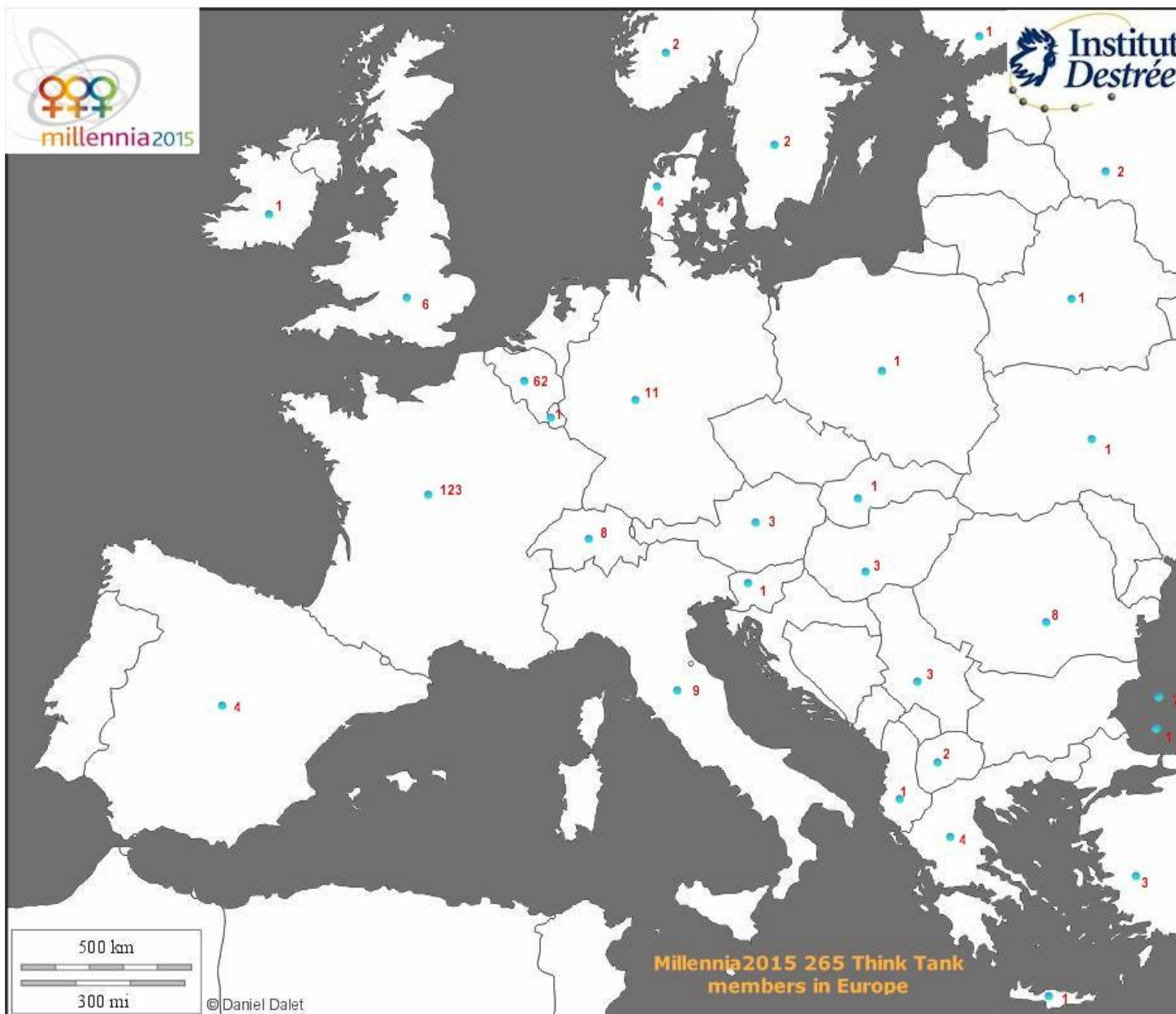
**Key values of Millennium2015:** equality between women and men; respect of rights and diversity; development of the human capital and the digital solidarity in order to empower women.

**Mission:** identifying the nature of the current and future changes; promoting a culture of respect of diversity and peace; recognizing and acknowledging the capacity of women to become actors and not victims of the social change, while developing a new worldview that can create a more sustainable life for all humankind; building women's networks of competence.

**Charter:** the members, collaborators and contributors of Millennium2015 are invited to sign the Millennium2015 charter: [www.millennia2015.org/charter](http://www.millennia2015.org/charter)

**Network:** Millennium2015 structure counts an active Think tank (registered members), global mail members and a list of contacts: 846 contributors, 2.732 members and 9.144 contacts in 107 countries in September 2012.

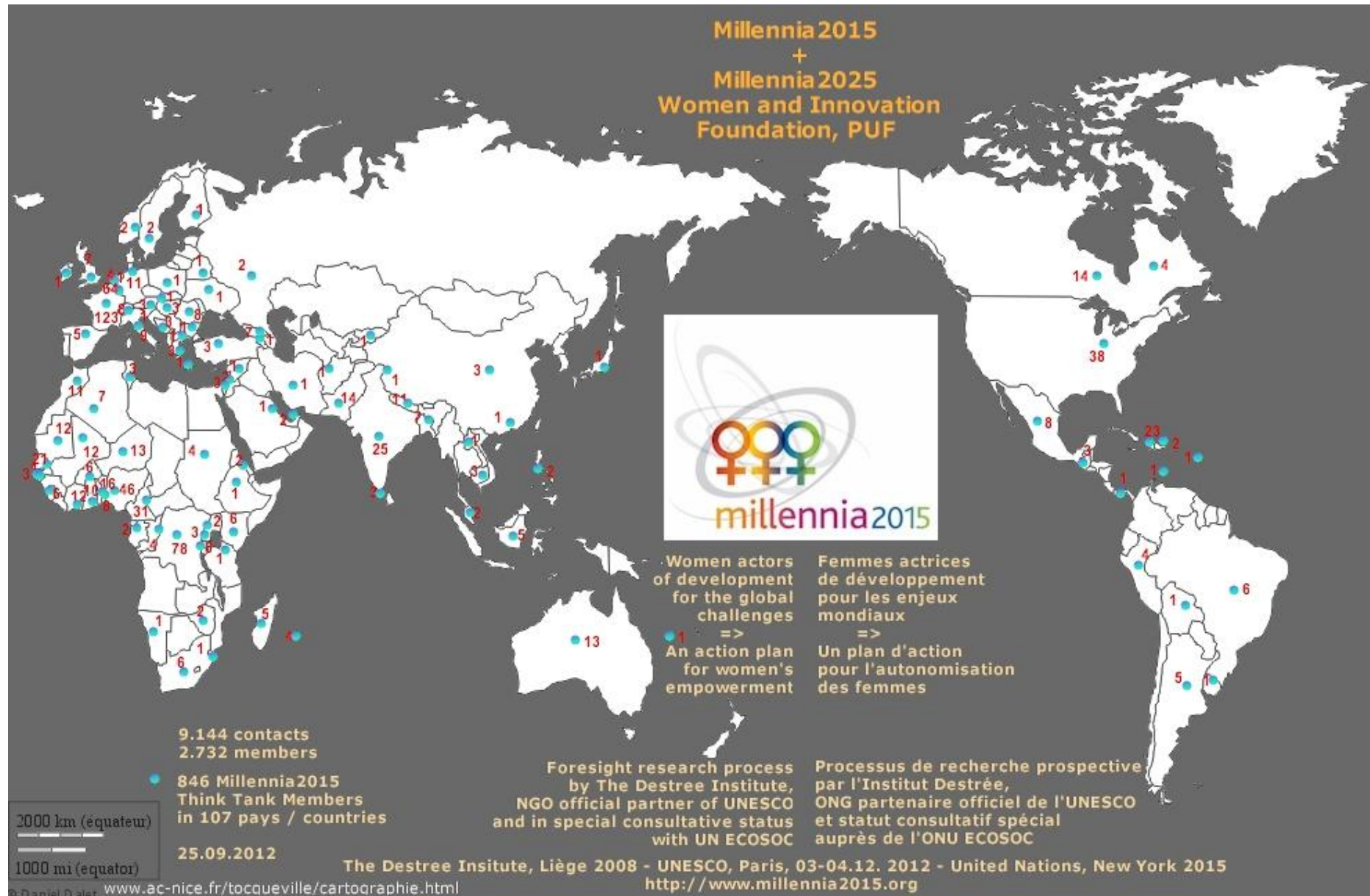

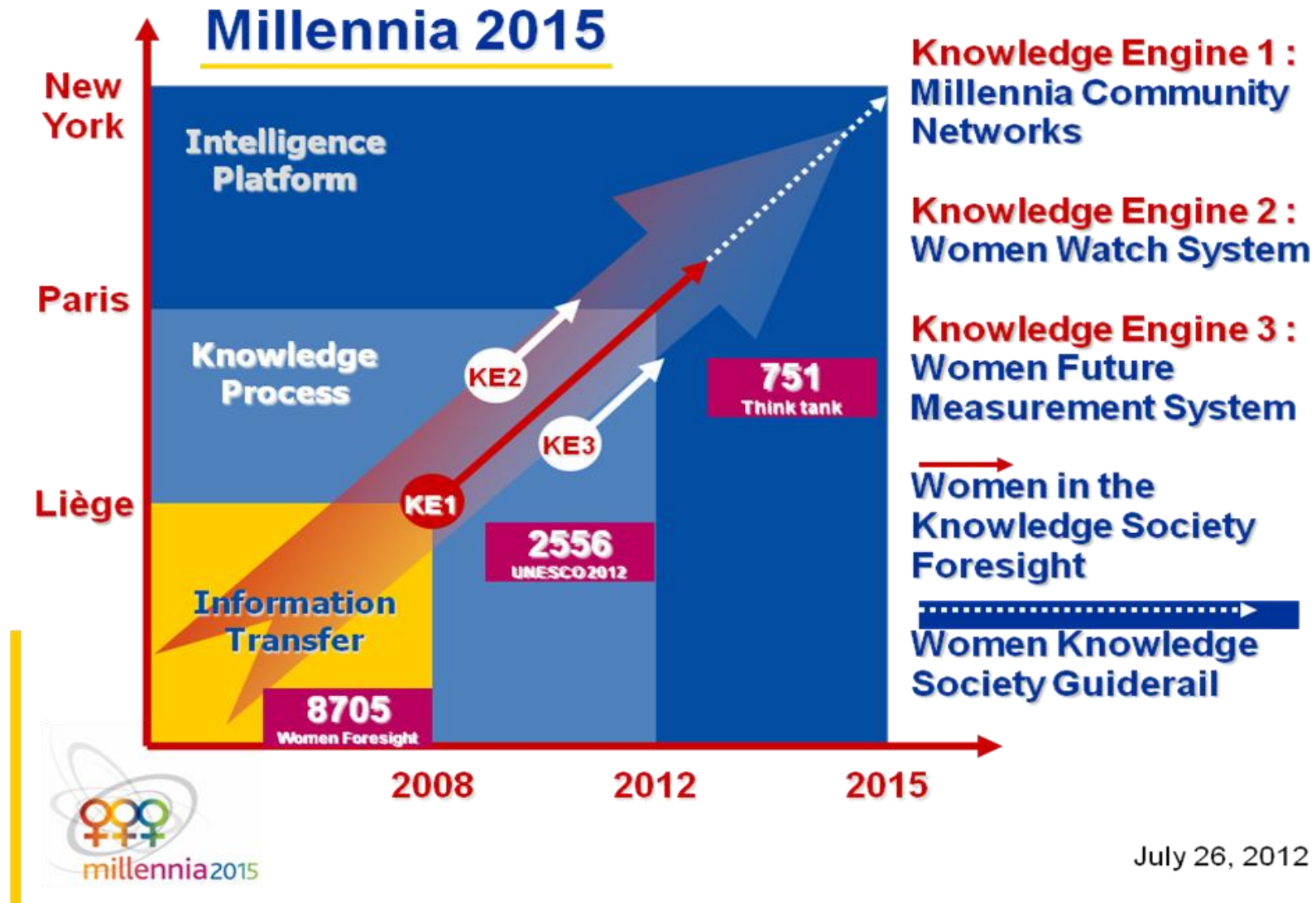

## 7. The importance for women and men to cooperate with Millennium2015

- Originality of the foresight methodology with a working plan structured until 2015;
- Collaborative work in the context of the information society in solidarity;
- Sincere cooperation without social divide, with respect, listening, trust and openness;
- Complementarity between all the stakeholders and civil society;
- Exchange of best practices, sharing of experiences and solutions;
- Development of regional/local communities of Millennium2015, particularly active: Benin, Mauritania, Nepal, DR Congo, Cote d'Ivoire, ...
- Development of Millennium2015 thematic International working groups (IWG) linked to the 37 variables of Millennium2015: "Women and eHealth" is the model, structured and very active. The other Millennium2015 IWG are in formation: "Women and Science", "Women and eSolidarity", "Women 1325", "Women and sport".

## 8. On-going foresight process

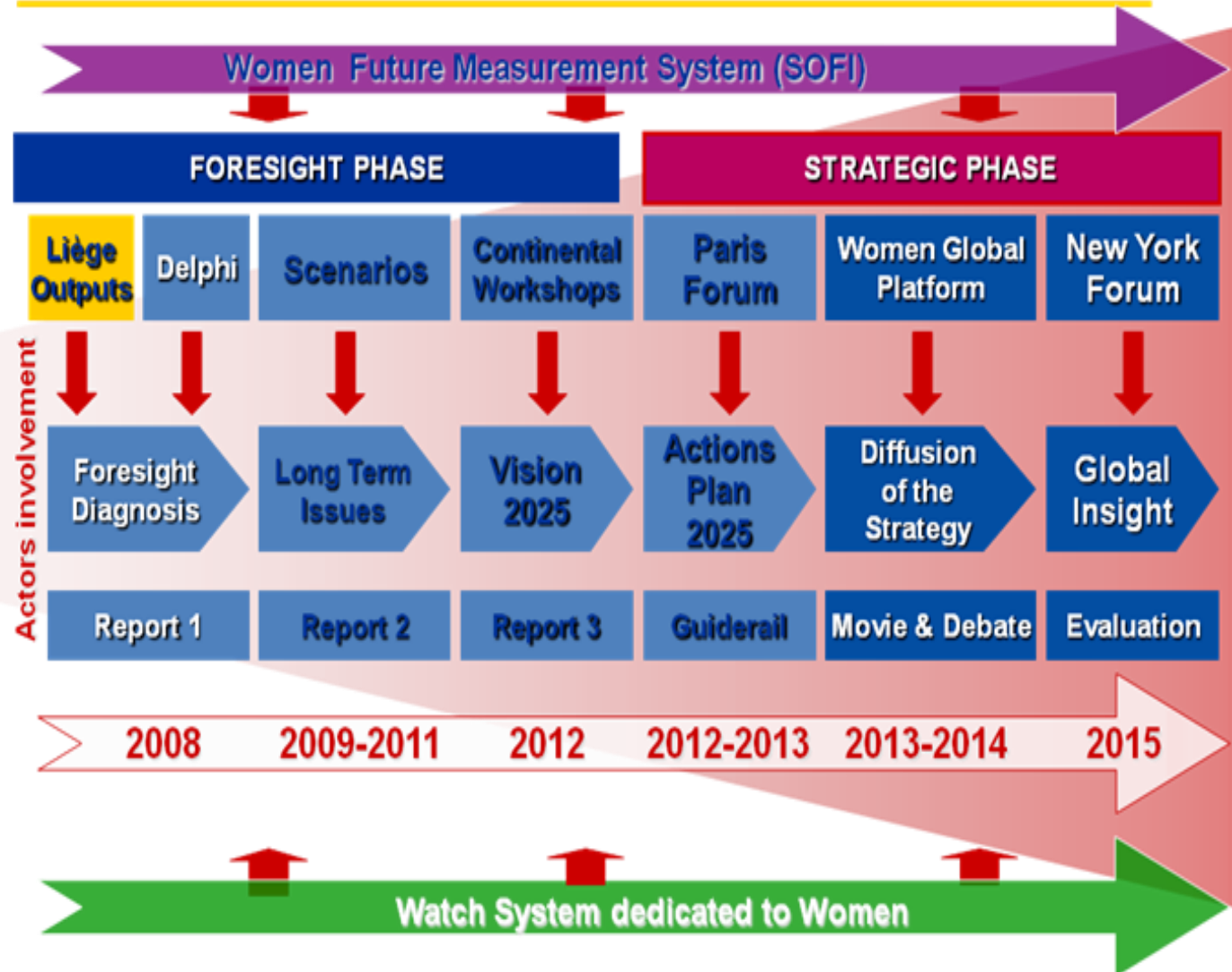
**2.1. The long term issues:** on the basis of the 37 variables, scenarios are developed by countries, regions or continents. Their main outputs are to formulate the long term issues: complex questions, problems, equations to which we will have to answer in order to build the strategy. They will be published by in October 2012.

**2.2. The vision(s):** built by countries, regions or continents, the visions will express, in respect of the Millennium2015 charter, the needs of women by the year 2025. A tentative of synthesis “The Millennium2025 LT Vision ?” will be published by the end of October 2012.

**2.3. A draft of Action Plan:** gathering the recommendations of the contributors for each issue, in order to answer the questions formulated and to reach the vision, a draft Action plan for women’s empowerment will be elaborated before the December Conference. Strategic axis and sets of actions will be published around November 15, 2012. It will be the first step to build the Millennium2025 Women Knowledge Society Guiderail.

10. **The long term issues:** complex questions, problems, equations to which we will have to answer in order to build the strategy.

Examples resulting from scenarios:

1. How to act on prejudices and sexist stereotypes in order for the whole society to be actually aware of these inequalities of status or wages and to be ready to change the situation?
2. How to balance cultural, ecological and economic matters between men and women in our society without one of the two feeling wronged?
3. How to answer to the will of civil society to reactivate values implying greater solidarity and more respect of the environment: what structure would be best suited to federate civil society and legitimate enough to drive real and profound social changes (association, NGOs, international organizations, political parties, qualified stakeholders)?



4. How and on what basis include women's development and research about gender equality issues in the major social reforms to be undertaken urgently, with the same importance as the ecological reforms?
5. How to concretely articulate parity with the related ways of thought and of governance?
6. How to reduce the international scourge of gender-based violence and to increase the involvement of men with women in tackling gender discrimination?
7. How to reduce the world-wide poverty and illiteracy of women and girls, and how to increase the opportunities for women in management in higher education?
8. How to promote the professional development of women in the workplace so that they can access to positions of high responsibility, while enhancing their privacy as effective experience?
