Brief description of duties and responsibilities

eHealth Unit – IER/KMS and HSE/ IHR (International Health Regulation)

During four years, I have been in charge of the evaluation of eHealth solutions in countries. The current work aimed at developing evaluation frameworks, strengthening collaborations and information sharing between WHO and UN agencies (ITU, World Bank), EU (ESA), NGOs and private partners (TATA industries, CISCO) to build alliances, forge partnerships, enhance cooperation among different actors on the use of Information and Communication Technologies (ICTs) to support healthcare delivery in poor settings.

Key achievements

Coordination of eHealth solutions in developing countries

The Information and Communication Technologies (ICTs) for health (or eHealth) cover a wide range of tools and solutions to fight poverty, outbreaks and humanitarian crisis and to contribute to the achievements of the MDGs. I am in charge to coordinate and evaluate their implementation in low income countries.

Reduction of vulnerabilities in humanitarian crisis: design of a web based Decision Support tool

to strengthen countries capacities to identify local vulnerabilities and make documented decisions during floods. A pilot tool is designed comprising a collection of more than 8.000 floods descriptions in the world and has been presented in WHO and ISDR. A study case was conducted in rural areas in **Mexico , India and Nigeria**. Local communities could share their experiences and local solutions to better face floods and reduce their impact on local populations. In the future it is envisaged to develop a web Knowledge Gateway.

Human resources for Health: eKnowledge Centers: contribution to the implementation of eKnowledge Centers in districts hospitals in **Ethiopia and Senegal**. In collaboration with Global Workforce Alliance for Health, a set of WHO eHealth applications and trainings are delivered to districts hospitals that are connected to the internet in order to strengthen health workers capacities through eLearning and access to web based portals (reproductive health, cancer prevention, early warning for epidemics, Telemedicine). <http://www.amdesign.ch/GHWA7/GHWA7/index.html>

mHealth : Health promotion through mobile phones: in collaboration with UNDESA and ECOSOC, I contributed to the implementation of UN Texting For Health Initiative in **Uganda and Ghana**. During 10 days, 10.000 people received 3 short messages (SMS) on their mobile phones on health promotion and prevention. Results were delivered at the ECOSOC meeting in Ghana (June 2009) and demonstrated the efficiency of using mobile phones for health promotion and the barriers to overcome in African countries . www.eatribune.com

Preliminary Study on Evaluation of eHealth projects in African countries: the objective of this preliminary study is to inventory, assemble and assess indicators and evaluation frameworks using published and grey information. The study collected and reviewed **311 eHealth projects in Africa**, implemented between 1999 and 2009. The analysis resulted in a list of 24 indicators most commonly cited and used for evaluation. They cover four categories: access, use, capacity building and cost.

WHO – mHealth Alliance – Health Metric Networks

High Level Working Session on the Development of Economic Models and Metrics in support of the Health related MDGs – Literature Review: eHealth models, methodologies and economic approaches towards a Business Case for countries. The review comprised a set of recent studies and publications representing more than 300 pages. Authors are based in major universities (Harvard, John Hopkins, Hawaii) or hospitals (Scotland Edinburgh, UK Birmingham), the European Union, OECD and the private sector. Case studies cover developed countries (Netherlands, UK, and USA) and developing countries in Africa and Latin America and report on eHealth, Telemedicine and mHealth projects. The literature review identified models and methodologies of emerging uses of ICTs to document future design of business models.

WHO – ITU – World Bank

Regional Forum Series on eHealth - National eHealth Strategies Toolkit – Development of the Concept Paper with the description of the basic elements of national eHealth plans, the process for identifying areas for improvement, new approaches and opportunities for achieving tangible outcomes and national scaling-up of interventions in a changed – and changing – environment. The proposed regional forum series will have a focus on developing countries particularly Sub-Saharan African countries. The first Forum is planned in Africa in 2012 and will invite 5 to 6 African countries to review and improve their eHealth strategies.

WHO - ITU

WHO conference and eHealth pavilion at ITU Telecom World 2009 - Geneva Palexpo, 5 to 9 October 2009: I contributed to organize a conference on “Connected Health” at the Forum and coordinated the “eHealth Pavilion” at the exhibition. More than 200 experts, government representatives, NGOs and industries attended the conference. The eHealth pavilion offered to visitors the demonstration of 10 eHealth solutions running in rural areas in developing countries and a series of 10 eHealth seminars during 5 days. Overall conclusions of the event will contribute to shape future working plans and partnerships between WHO and ITU.

I conducted **audits and evaluations** in **developing countries** (Madagascar, Venezuela, Morocco, Senegal, Thailand...). Missions were focused on evaluation of **access to primary health care** (in particular for children under 5 and woman), to **education and schools** (young girls) and the **reduction of the digital gap** in remote places (deserts, Amazonian forests). They cover **communicable diseases and epidemiology** notably Tuberculosis (Algeria, Morocco, Tunisia), Malaria (DRC), Buruli Ulcer (Cameroon), Leishmaniasis (Jordan). Hereunder, a summary of missions realized in 2004/2005:

2004/2005 – EU-ECHO Economical evaluation of Humanitarian Actions in DRC

Objective: Humanitarian actions in Democratic Republic of Congo require a high level of investment in Public Health (\$ 17 millions/year) related to a no war no peace unstable political environment. The consulting team was composed with 4 international experts and visited 16 NGOs, 37 hospitals, 40 dispensaries and interviewed 150 medical officers and nurses during 3 months. The overview of the humanitarian action was based on field analysis, public health assessments, monitoring & evaluation of drugs distribution and access to primary care for vulnerable populations (mothers, children under 5).

Results: The final report related 87 recommendations to assist EU-ECHO to develop a performance oriented Global Plan strategy in DRC for 2005-2009.

2004/2005- EC Evaluation of the Telemedicine European Program, EMISPHER

EMISPHER (Euro-Mediterranean Internet-Satellite Platform for Health, Education and Research) is a project co-funded by the European Commission in the frame of the program EUMEDIS that aims at promoting cooperation between the countries of the Mediterranean area.

Objective: During 2 years (2002/2004), the European Commission launched an ambitious program of deploying satellite network in 10 countries (4 in Europe and 6 in African countries) to deliver a Virtual Medical University, Real Time Telemedicine, Medical Assistance, electronic portal, dissemination tools and distance learning programs. <http://www.ehto.org/2005/eumedis.htm>

Results: The evaluation was focused on the performance of access to health care using distant technologies and satellite services in countries (**Egypt, Morocco, Lebanon, Cyprus**) and its long term local sustainability. It provided comprehensive recommendations for 2005-2007 period and ensured the design of the future Virtual Euro-Mediterranean Hospital (VEMH). www.emispher.org

2003/2004 –EC/ European program, EMPHIS

EMPHIS (Euro-Mediterranean Public Health Information Systems) is a 3 year projects funded by the European Commission that aims at establishing health information systems among 16 countries in Europe and Africa to reduce the burden of tuberculosis, leishmaniasis and nosocomial infections.

Objective: the project is based on the development of the health information system using electronic records and an a network of health institutions to deliver e-learning, an interactive portal, regular information and newsletters to a wide range of health care providers, including those in rural areas.

Results: At mid-term, the project was currently delivering e-learning on nosocomial infections and tuberculosis to more than 200 nurses and medical officers in **Lebanon, Algeria and Egypt**. A geographical information system (GIS) was in place to investigate and reduce actively the expansion of leishmaniasis in rural areas in south **Jordan** and east **Morocco**. The portal was receiving more than 100 requests per week among the scientific community. www.emphis.org

The most sensitive key point remained the sustainability of the project after the end of the EC funding.
